## Annual Meeting to be Held Later in 2021

In September 2020, members voted to approve the cooperative's bylaw amendments. Part of the changes included removing the requirement for Pioneer Electric to hold its annual membership meeting in either February or March. With the vote of approval, Pioneer Electric may host the meeting any time between Feb. 1 and Oct. 31 of a given year. The bylaw change allows Pioneer Electric added flexibility to reschedule or adjust the meeting's date if needed to better serve its members.

"As we saw last year, you never know what type of situations may arise," said Martie Floyd, president of Pioneer Electric's Board of Trustees. "We want to be able to serve our members in the greatest possible capacity. By having a more flexible time frame to hold the annual meeting, we're able to choose a date that will best benefit our members."

Pioneer Electric's Board of Trustees will take into consideration the health and safety of its members when choosing a date for the 2021 annual meeting.

"Now that we have the opportunity to host the annual meeting outside of early spring, we have the chance to find a date that may not be impacted by snow or icy conditions," said Floyd. "We will also be able to work around school or other community events."

The health fair, traditionally held the same day as Pioneer Electric's Annual Meeting, will also be held at a later date.

"We understand that members look forward to attending the health fair on annual meeting day," said Anita Wendt, vice president of energy services. "Pioneer Electric will continue to work with county health officials to help keep our communities healthy. As 2021 progresses, we will continue to make choices that help us do that."

## Pioneer Electric Awards Youth Tour Scholarships

In late 2020, four students were selected to represent Pioneer Electric on all-expenses-paid trips to Washington, D.C., and Steamboat Springs, Colorado. Due to concerns with the pandemic, Kansas Electric Cooperative's (KEC) board of directors decided to cancel both programs for summer 2021. Instead, Pioneer Electric will offer a \$1,000 scholarship to each winner.

Judges selected Ulysses High School students **BECCA ROCK** and **BRYAN PEÑA** to represent the cooperative in Washington, D.C. **EMILY NUNEZ**, Ulysses High School, and **HANNAH EVANS**, Elkhart High School, were chosen to represent Pioneer Electric in Steamboat Springs, Colorado. The four students were finalists out of a pool of 12 candidates from schools in Pioneer Electric's service territory, after completing an online application and interview.

"We know that our students were looking forward to this trip, but the health and safety of our students, and their families, is our priority," said Rae Gorman, manager of energy services. "Pioneer Electric understands that we can't replace the experiences these trips would have provided. We hope these students will be able to use these scholarships to help them achieve their goals beyond high school."

Students selected for the 2021 trips will have the opportunity to apply for the 2022 program, provided they meet the program's requirements. Any students who age out of the program will be eligible to apply for Pioneer Electric's general scholarship their senior year of high school.

# Pioneer Electric Donates Funds from UOM School to Pheasant Heaven Charities

Representatives from Pioneer Electric presented Pheasant Heaven Charities with a check for \$14,352.52 on Jan. 8. Funds for the donation were available due to the disbanding of the Underground, Overhead, Metering (UOM) School. Beginning in 1974, the UOM school provided training to linemen and kept them up-to-date on new tools and products used in electrical power distribution. The non-profit training event, sponsored by Pioneer Electric, Wheatland Electric and the City of Garden City Electrical Department, formally disbanded in 2020.

“We wanted to ensure that these funds, created in southwest Kansas, were given back to a southwest Kansas organization,” said Mike Haney, a former board member for the UOM school and manager of engineering and operations at Pioneer Electric. “Pheasant Heaven Charities goes above and beyond to assist those in need throughout our region.”

Pheasant Heaven Charities will use the donation to assist individuals dealing with medical needs. Additionally, the charity will use the money for their scholarship program and

in supporting other organizations throughout southwest Kansas and the Oklahoma Panhandle.

Pheasant Heaven Charities’ goal is to support individuals with medical needs. In addition to its benevolent assistance program, Pheasant Heaven Charities provides support to cancer patients within a 50-mile radius of Hugoton through its Love From Above committee. 

### YOUTH TOUR
